

MEMORANDUM OF UNDERSTANDING
BETWEEN
SAINT-PETERSBURG STATE UNIVERSITY, RUSSIA
AND
TRIBHUVAN UNIVERSITY, NEPAL

This Memorandum of Understanding is made between Saint-Petersburg State University, Russia (hereinafter called "Saint-Petersburg University") and Tribhuvan University, Nepal (hereinafter called "Tribhuvan University").

WHEREAS Saint-Petersburg University and Tribhuvan University acknowledge a desire to establish certain co-operations programs beneficial to their respective educational institutions and to promote the development of joint studies, research and training activities, and other educational programs of mutual interest.

NOW THEREFORE THIS MOU WITNESSES AS FOLLOWS:

AGREEMENT

That in contemplation of the relationship to be established, the parties herein agree as follows:

- I This agreement is not to be considered a contract creating legal and financial obligations between Saint-Petersburg University and Tribhuvan University. It is designated to facilitate and develop genuine and mutually beneficial study programs, research relationship and exchange programs.
- II It is agreed that Saint-Petersburg University and Tribhuvan University will work together to promote the following:
 - a) Exchange of Students;
 - b) Exchange of Members of the Faculty and Administrative Staff exchanges;
 - c) Exchange of materials, documents and equipment;
 - d) Collaborative research in any field of interest to both Universities;
 - e) Creation and organization of conferences;
 - f) Any other activities mutually agreed upon both Universities.
- III Specific mechanisms and conditions for the implementation of particular cooperative and collaborative activities mentioned above shall be established by the parties and described in writing as appendixes or additional protocols/agreements to the present Memorandum.

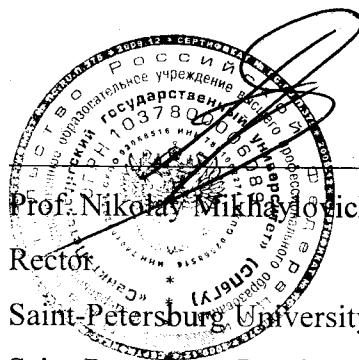
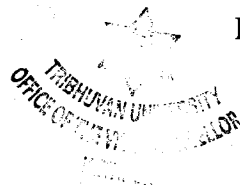
- IV This agreement, when executed by the parties, shall become effective immediately from the date of signing by the both parties and shall have the validity for a period of five years.
- V Resources for implementation of this agreement may come from either party, depending upon budgetary availability. Neither part is obligated to expend any resources in connection with this agreement. No implementation of any portion of this agreement or commencement of any specific projects may be initiated prior to the written assurance of adequate budgetary resources.
- VI This agreement may be renewed for a further period by mutual consent of the Saint-Petersburg University and Tribhuvan University. Renewals shall be in writing and subject to the same terms and conditions set forth herein.
- VII The parties shall cooperate mutually to resolve any dispute or misunderstanding through collaboration and discussion.
- VIII Either party shall have absolute right to terminate this agreement with or without cause upon thirty (30) days prior written notice to the other party. Such termination shall not affect students already enrolled and participating in a program at the host institution.

IN WITNESS WHEREOF, the authorized representative(s) of Saint-Petersburg University and Tribhuvan University have executed two copies of this Agreement on this 18th Day of August in the Year Two Thousand and Ten.
